It is humbling that I must receive important Aquaculture Program information (attached) from people outside the ARS, but it has recently been suggested that I just accept these behaviors as the way ARS is entitled to conduct its business.

However, I will take this opportunity to ask (again) that I please be kept in the loop on pertinent matters that concern Peter's and my CRIS project. Thank you.

Don McLellan (ARS Director of Civil Rights) has recently informed me that he (and other Agency employees) have examined my EEOC complaint and they can find no evidence of discrimination ever having occurred here in Alaska's ARS unit. Therefore, he and Edward Knipling (ARS Administrator) do not support my request that I be assigned to another supervisor until the EEOC has ruled on the merits of my case.

As you are aware, it continues to be exceedingly uncomfortable for me here in your unit, but ARS personnel are refusing to separate us. To make the best of this unfortunate situation, I have been advised to document every event that I consider retaliatory.
